

PRIVACY POLICY- DAZZ TECH PRIVATE LIMITED

DAZZ Tech Private Limited (referred to herein as the "Company," "we," "us," or "our") respects the privacy of its customers, direct sellers/distributors, and website/application users. This policy explains how we collect, use, disclose, and safeguard your Personal Information.

1. Information We Collect

We may collect Personal Information through various means, such as when you use our products or services, register as a distributor, or contact us.

A. From Customers

- **Identity & Contact Information:** Name, address, email address, phone number.
- **Financial Information:** Payment details such as bank account information or credit/debit card details (only when necessary for transactions).
- **Transaction Details:** Product purchase history, order details.

B. From Direct Sellers/Distributors

In addition to the information above, we also collect the following information from distributors:

- **Identity Documents (KYC Compliance):** PAN Card number, Aadhaar Card information (where required for legal compliance).
- **Financial and Incentive Information:** Bank account details, tax-related information, commission and bonus details.
- **Performance Data:** Sales, recruitment, team structure, and training information.
- **Date of Birth and Gender.**

2. How We Use Your Information

We use your Personal Information for the following purposes:

- **To Provide Services:** To supply products, process orders, and manage payments.
- **Distributor Management:** To register and manage distributor accounts, and to pay commissions and bonuses.
- **Communication:** To contact you about products, services, promotions, and changes to policies.
- **Legal and Regulatory Compliance:** To comply with Direct Selling Rules and other applicable laws in India (such as Income Tax, GST, DPDP Act, 2023).
- **Improvement and Analysis:** To analyze data to improve our services, products, and business operations.
- **Marketing and Promotion:** To send you information about our company's products and opportunities (where you have given consent).

3. Disclosure and Sharing of Information

We may share your Personal Information only in the following circumstances:

- **With Distributors:** Limited information (such as name and contact details) with your upline/downline distributors, only as necessary to support and manage the business.

as necessary to support and manage the business and to track sales incentives/commissions.

- **With Service Providers:** With reliable third-party service providers who perform services on our behalf, such as warehousing, shipping, payment processing, and IT support.
- **Legal and Regulatory Requirements:** When required by law, or upon request by government/regulatory authorities.
- **Business Transfer:** In the event of a merger, acquisition, or sale of assets.

We **do not sell or rent** your Sensitive Personal Data to any third party **without your explicit consent**.

4. Your Consent

By registering as a distributor or conducting a transaction with us, you **consent** to the collection, use, storage, and disclosure of your Personal Information in accordance with this Privacy Policy.

5. Security of Your Information

We implement appropriate technical and organizational security measures to protect your Personal Information from unauthorized access, alteration, disclosure, or destruction.

6. Your Rights

You may be entitled to the following rights:

- **Right to Access:** To request access to and receive a copy of the Personal Information we hold about you.
- **Right to Correction:** To request correction of any inaccurate or incomplete Personal Information.
- **Right to Erasure (Deletion):** To request the deletion of your Personal Information when it is no longer necessary for the purposes it was collected, subject to applicable tax and financial record-keeping laws.
- **Right to Withdraw Consent:** To withdraw your consent at any time, without affecting certain services.
